

RIOREY SOFTWARE LICENSE AGREEMENT

THE SOFTWARE TO WHICH YOU ARE REQUESTING ACCESS IS THE PROPERTY OF RIOREY, INC. (RioRey). THE USE OF THIS SOFTWARE IS GOVERNED BY THE TERMS AND CONDITIONS OF THE AGREEMENT SET FORTH BELOW. BY USING THE SOFTWARE, YOU ACCEPT THOSE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THE AGREEMENT, DO NOT USE IT AND RETURN THE SOFTWARE AND ACCOMPANYING HARDWARE AND DOCUMENTATION TO RIOREY.

1. **Ownership of the Software.** The software contained in the RIOREY NI, RX AND RE PRODUCT SERIES (“the Software”), is owned or licensed by RioRey and is protected by United States copyright laws, laws of other nations, and/or international treaties.
2. **Grant Of License.** RioRey hereby grants to you the right to install and use the Software solely with the associated Hardware that accompanied it, and for no other use.
3. **Restrictions on Use and Transfer.** You may not otherwise copy the Software, except that you may make one copy of the Software solely for backup or archival purposes. To this end, you may transfer the Software to a single set of disks provided you keep the disks solely for backup or archival purposes. You may not copy the written materials and you may not use the backup or archival copy of the Software except in conjunction with the RioRey NI, RX and RE version product you ordered.
 - (a) You may not transfer the Software to any third party without the express written permission of RioRey. For permitted transfers, you may not export the Software to any country for which the United States requires any export license or other governmental approval at the time of export without first obtaining the requisite license and/or approval. Furthermore, you may not export the Software in violation of any export control laws of the United States or any other country.
 - (b) You may not modify, translate, decompile, disassemble, use for any competitive analysis, reverse engineer, distribute, or create derivative works from, the Software or accompanying documentation or any copy thereof, in whole or in part.
 - (c) The subject license will terminate immediately if you do not comply with any and all of the terms and conditions set forth herein. Upon termination for any reason, you (the licensee) must immediately destroy, or return to RioRey, the Software and accompanying documentation and all copies thereof. RioRey is not liable to you for damages in any form solely by reason of termination of this license.
 - (d) You may not remove or alter any copyright, trade secret, patent, trademark, trade name, logo, product designation or other proprietary and/or other legal notices contained in or on the Software and accompanying documentation. These legal notices must be retained on any copies of the Software and accompanying documentation made pursuant to paragraphs 2 and 3 hereof.
 - (e) You shall acquire no rights of any kind to any copyright, trade secret, patent, trademark, trade name, logo, or product designation contained in, or relating to, the Software or accompanying documentation and shall not make use thereof except as expressly authorized herein or otherwise authorized in writing by RioRey.
4. Any notice, demand, or request with respect to this Agreement shall be in writing and shall be effective only if it is delivered by hand or mailed, certified or registered mail, postage prepaid, return receipt requested, addressed to RioRey, whose address is set forth below. Such communications shall be effective when they are received by RioRey.
5. **Limited Software Warranty.** RioRey warrants the Software, as delivered by RioRey and properly installed and operated on the Hardware or other equipment it is originally licensed for, to function substantially as described in its accompanying user manual during its respective warranty period which begins on the date Software is first shipped to Customer. RioRey does not warrant that any item of Software or a Software Release is error-free or that

its use will be uninterrupted. RioRey is not obligated to remedy any Software defect which cannot be reproduced with the latest Software Release. These warranties do not apply to any Product which has been (i) altered, except by RioRey or according to its instructions, (ii) used in conjunction with another vendor's product resulting in the defect, or (iii) damaged by improper environment, abuse, misuse, accident or negligence. Replacement parts furnished under this warranty may be refurbished or contain refurbished components. If any item of Software fails to so function during its warranty period, as the sole remedy, RioRey will provide a suitable fix, RIOREY'S LIMITED WARRANTY IS SET FORTH HEREIN AND ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES. RIOREY, AND ITS SUPPLIERS OR LICENSORS MAKE NO OTHER WARRANTIES, EXPRESS OR IMPLIED, EITHER IN FACT OR BY OPERATION OF LAW, STATUTORY OR OTHERWISE, RELATING TO ITS PRODUCTS, INCLUDING THE RIOREY SOFTWARE AND ACCOMPANYING HARDWARE AND RELATED DOCUMENTATION OR USE THEREOF AND EXPRESSLY EXCLUDES AND DISCLAIMS ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. MOREOVER, THE PROVISIONS SET FORTH IN SUCH LIMITED WARRANTY STATE RIOREY'S ENTIRE RESPONSIBILITY AND CUSTOMER'S SOLE AND EXCLUSIVE REMEDY WITH RESPECT TO ANY BREACH OF ANY WARRANTY.

Customer agrees that RioRey's liability to Customer in any way connected with the Products, Services or use thereof, regardless of the form of action, shall in no event exceed the price paid by Customer for such Products or Services.
